This is not a schedule; activities and courses are scheduled on an on-going basis by the provider and all inquiries regarding scheduling should be referred to the provider. Scheduling and cancellations of activities and courses are a matter of individual provider policy over which the Real Estate Commission has no control. Providers of education are listed in alphabetical order and contact information may be found for each entity.

For courses to be used for licensing purposes, students must complete 100% of the course or activity; the course must have been taken while the course was recognized by the Real Estate Commission and for the total number of hours certified.

Only Post-License course number 7000 can be used to complete your licensing requirements. Each licensee has 180 days from the date of licensure to complete the 12-hour course 7000. If the course is not completed and reported within the 180 days, your license shall be placed on inactive status until the commission receives such satisfactory evidence.
